In print, mobile apps, electronic publications, websites, films and videos.

UP TO 5 USERS

Our standard license gives you the right to install the fonts on up to 5 computers within your company. Under certain terms, you additionally may provide the fonts to your printer or web developer.

THIS END-USER LICENSE AGREEMENT (EULA) IS A LEGAL CONTRACT BETWEEN YOU (END-USER) AND ALTIPLANO (SUPPLIER). BY DOWNLOADING, INSTALLING AND/OR USING THE FONT SOFTWARE YOU CONFIRM THAT YOU HAVE READ AND ACCEPTED THIS EULA.

COPYRIGHT OWNERSHIP OF PRODUCT GENERAL LAWFUL USE Digital typefaces are both design and computer softwares. The intellectual property of the design contained in the font softwares is owned by Altiplano. The structure, organization and code of the font software are the valuable trade secrets of Altiplano. You have purchased a non-exclusive license which grants you certain rights to use the font softwares; It does not grant the right for sale of the font software, of its design or any portion of it. Except for your right to use the font softwares granted by this license, all other rights are owned and retained by Altiplano.

Altiplano hereby grants you a limited and non-exclusive license to install and use the font software on the number of computers which is specified in the order. These computers have to belong to the Licensee which is specified in the invoice. The end-user is allowed to create one (I) copy for back-up use only. Each device containing the font software counts as one computer.

You are not authorized to sublicense, sell, lend or lease the font software. You are allowed to send a copy of the font software to a printer or any service company for final output. The printer or the service company will have to destroy any copy of the font software upon completion of the work. You further agree to inform the printer or other service company about the content of this EULA. You may: a) not convert, modify or rename the original font software under any circumstance; b) not open the original font software in an editing software in order to reveal its structure, organization or code; c) not use the original font software file to create a derivative or modified product or design, including creating characters for alphabets and languages not covered by the typeface or designing a custom version of the typeface; d) not modify the design of the characters contained in the font software, even if converted to outlines with the help of an editing or design software.

STANDARD/MULTI-USER LICENSE

It is possible to upgrade the number of CPUs allowed, the Licensee must purchase additional licenses contacting Altiplano directly.

The Licensee may install the font software on a single file server for use on a single Local Area Network (LAN) only when the use of the font software is limited to the workstations and printers that are part of the licensed unit. Each workstation connected to the LAN counts as one computer from the total al-

lowed amount stipulated in your order. The font software may not be installed or used on a server that can be accessed via the Internet, via another external network system (a system other than LAN) or by workstations which are not part of a licensed unit. For embedding in website, see Self-Hosting And Embedding.

COMPATIBILITY AND USAGE Altiplano provides OpenType/CFF (.otf) desktop font formats. WOFF2 (woff2), WOFF (woff) and TTF (.ttf) files are included in all font packages, except animated styles, which are generated under JSX (.jsx) and JSON (.json) font formats. Altiplano guarantees that the font softwares downloaded from

its website are valid fonts, installable and printable. It's a matter of the systems, softwares versions or browsers whether they support OpenType fonts and features: please refer to your system/software/browser documentation.

BUYING THE FONT FILES ON BEHALF OF A CLIENT PROVIDING FONT FILES TO THIRD PARTIES Altiplano allows you to buy our font softwares from us on behalf of a client under the following conditions: a) the client must be registered as the Licensee during the checkout process; b) You have to provide your client with a copy of the EULA. The EULA has to be accepted by the client; c) you have to provide your client with the original invoice related to the purchase.

Altiplano does not authorize to invoice our font software to your client at another price as the one displayed on our website.

We allow you to provide the fonts to your printer and web developer working for you, with regard to the following conditions: a) you may, for a defined time period, provide a copy of the font software you have used for a particular file to a commercial printer or other pre-press facility in the scope of a defined project, only in order to prepare for printing and print your documents.

b) You may, for a defined time period, provide a copy of the font software you have used for a design to the company coding the website or the mobile application in the scope of a defined project, only in order to implement the font software into the website or the mobile application. Any design and/or editorial work is excluded from this particular agreement. Your personal license is not transferred to the company or people in question and the font software may be used exclusively in order to accomplish the work specified in the contract between you and the company. The printer or the service company will have to destroy any copy of the font software upon completion of the work. You further agree to inform the printer or other service company about the content of this EULA.

SELF-HOSTING EMBEDDING: SPECIFIC LAWFUL USE Altiplano grants the end-user the right to embed the fonts on an unlimited number of websites, mobile apps and electronic publications under the following conditions: a) anyone having the font software on his computer in order to use it for a screen/digital project have to possess a license of it (exceptions apply as described under Providing the fonts to third parties). b) You are entitled to embed the licensed font software in a secured read-only mode, subject to the following restrictions: you shall secure embedded documents against unauthorized use by any third party. c) You are not authorized to embed the licensed font software for the purpose of allowing third parties to create new documents or designs.

Any embedding not described below is prohibited. Altiplano may include additional authorized embedding in the future.

WEB. Only the original webfont files delivered can be used as webfonts (WOFF and EOT formats) The fonts have to be stored on the same server as the other softwares and assets associated with the licensed domains. Technologies other than @font-face are not allowed. The use of third party font hosting services is strictly prohibited.

MOBILE APPS. You are granted to embed the font software in apps running on iOS, Windows Mobile and Android mobile operating systems. Only the OTF (.otf) files delivered can be used in your mobile app(s).

ELECTRONIC PUBLICATIONS. You are granted to embed the fonts in Portable Document Format (.pdf), EPUB (.epub), iBook (.ibooks), Kindle (.azw, kf8) documents. Only the OTF files (.otf) delivered with your order can be used in your electronic document(s).

WARRANTY AND LIABILITY

Altiplano warrants that the font software will perform in accordance with the specifications published on its website. The font software may be exchanged only if defective and will be replaced only when accompanied by a valid sales receipt within thirty (30) days of purchase.

Designers can use our Free Trial Files for testing purpose only. All our font formats are included in our Free Trial package, in order to test them in your prints, websites, mobile apps and electronic publications. The end-user is not authorized to embed the font software in any document, application, website or video stream which could be accessible publicly or by a third party.

Exceptions apply for students. As a student you can use our Free Trial Files for your school projects. You can embed the Free Trial Files for any non-commercial work in the scope of your studies. Your projects can be accessible publicly. Communication projects of all kind are not allowed and require the purchase of a license.

This Agreement is valid in all territories and has no expiration date. It will terminate automatically if you fail to comply within its terms. Any dispute regarding the validity, performance or interpretation of this agreement shall be subject to the exclusive jurisdiction of the laws of Switzerland.
